# IMPORTANT MOUINSTRUCTIONS

There are likely some benefits in our current MOU of which you may not be aware. For example, books that you are required to purchase for your role can be reimbursed through the county. Additionally, Inspectors I and II qualify for a bonus upon successfully passing all 8 CDFA certificate exams. Inspectors III can apply for a bonus after passing the CDFA Deputy exams. Additionally, Inspectors I and II can get CDFA exam fees reimbursed. Proof of purchase and passing transcripts must be submitted when filing for reimbursement.

If you are in the Weights & Measures Bureau and looking to network, you may have 100% of your annual membership cost paid by the county NCWM. Non-WM union members can have 50% of NCWM, CASAP and PAPA membership fees covered. Let's not forget about our uniform benefits. While we are entitled to class "B" uniforms, we can upgrade to class "A" and only pay the difference. Union members can also replace the heavier lined jacket with a lighter duty jacket. We are entitled to reimbursement for necessary uniform replacements and alterations up to \$50 per year. Lastly, a yearly \$100 work boot reimbursement is available. Please contact your supervisor before purchase as each department has its own requirements approving work boot suitability.
